AFTER SCHOOL CARE AGREEMENT

1. Agreement. Upon return of this completed and signed After School Care Agreement and a refundable deposit of \$75.00, no later than May 1, 2010, a place will be reserved for the above named student to attend Eagle Cove School's After School Care Program beginning September 2010. Please be advised that the availability for placement for After School Care is limited. Agreements are accepted on a first come, first serve basis.
2. Payment. In consideration of the acceptance of the student for the 2010-2011 academic year, the undersigned Parent and/or Legal Guardian agree(s) to pay the After School Care fee. I agree to a monthly payment plan provided by the school. The first payment is due September 1, 2010. The last payment is due April 1, 2011. Payments are to be made over nine (8) months, each payment due the first of each month.
 - A deposit of \$50.00 payable to ECS by May 1, 2010
 - The first payment is due at ECS by September 1, 2010
 - The last payment is due at ECS by April 1, 2011
 - All monthly payments are due the first of each month. *A service charge of \$25.00 will be attached to the account for any payments not received by the first of each month.*
3. Miscellaneous. The terms of this Agreement are subject to the School's rules and regulations, which are set forth in the Parent Handbook as applicable, and as such rules and regulations may hereafter be amended from time to time. All such rules and regulations are incorporated in this After School Care Agreement. The school or the student may cancel this agreement by providing written notification to the other party within thirty (30) days of the desired cancellation date.
